

DESCRIPTION: BIO-MAGIC is a biological product with spores and mycelial fragments of a naturally occurring entomopathogenic fungus *Metarhizium anisopliae*. It is used in the control of Aphids, White flies, Mealy bugs in Roses & French beans and Thrips, Aphids, Whiteflies, Tuta absoluta in Tomatoes

MODE OF ACTION: When the spores of *Metarhizium anisopliae* come into contact with the skin of target insects, they germinate and grow directly through the cuticle to the inner body of their host draining the insect of nutrients and eventually killing it in about 3-5 days.

DIRECTIONS OF USE: Mix the required amount of BIO-MAGIC with water and stir thoroughly. Add this mixture to the spray tank and top up to the required amount of water. Spray the crop thoroughly to ensure good coverage.

RATES OF USE:

PRE HARVEST INTERVAL: 0 days.

APPLICATION FREQUENCY: Once per week for 4 weeks. If insect pressure is high continue weekly applications.

PHYTOTOXICITY: Non-phytotoxic on most crops. However, always undertake tests on small areas before large-scale application.

PRECAUTIONS: This product is relatively safe to spray operators. However, avoid contact with bare skin and eyes, inhalation of spray mist or swallowing of the product. Wear protective clothing including gloves, face shield, hat, gumboots etc. when handling or spraying the product.

STORAGE AND DISPOSAL: Store in tightly closed original container in a cool dry and well ventilated place away from children, livestock, food and feedstuff. It should be stored at 20-25°C. Triple rinse empty container and add washings to spray mixture, then dispose empty container in a safe and authorised place away from human habitation and water sources, in accordance with national regulations and legislation. Do not reuse containers for any other purpose.

ENVIRONMENTAL HAZARDS: BIO-MAGIC is bio-degradable, eco-friendly and environmentally safe. It is safe to honey bees, beneficial insects and it is not toxic to fish. However, do not contaminate ponds and waterways by direct application, cleaning equipments, disposal of waste and empty containers.

TOXICOLOGICAL INFORMATION: Symptoms of poisoning. Over exposure may cause eye or skin irritation. May be harmful if inhaled or ingested. **Antidote:** Treat symptomatically.

FIRST AID INSTRUCTIONS: **Skin contact:** Wash with soap and plenty of water. **Eye contact:** Wash with running water for at least 15 minutes. **If ingested:** Induce vomiting by drinking water. Seek medical attention immediately. Do not give anything by mouth to an unconscious person. **Inhalation:** Remove victim to fresh air. If not breathing give artificial respiration.

Antidote: No specific antidote.
