DESCRIPTION. MancoFlo 455 SC is a liquid suspension concentrate of mancozeb for control of Botrytis (both flowers and stem) in Roses, Anthracnose on French beans, Early & Late Blight in Tomatoes and Anthracnose & Ascochyta Blights in Peas. It has no need for pre-mixes hence saves time and labour. Easy to pour and measure, no dust inhalation and minimum exposure to hazard. It is less abrasive to expensive spray equipment.

N.B: Roses: Mancozeb when used at the recommended rates does not cause phytotoxicity. Always check for varietal tolerance on a few plants.

RECOMMENDATIONS FOR USE

- Spray MancoFlo 455 SC in a preventative programme.
- MancoFlo may leave some residues on some plants and it is advisable to check out on some few plants before application.
- Use spray volumes of 1000 litres per Hectare and spray to wet the plant.
