**JINSI YA KUTUMIA:** Matokeo mazuri hupatikana dawa hii ikitumiwa kwa mazuizi ya ugonjwa lakini pia huzuia kuenea kwa ugonjwa ikinyuniziwa baada ya mashambulizi. Ni muhimu kubadilishana Pearl 80DF na dawa zingine za kuzuia magonjwa ya kuvu ili luepuka uwezekano wa vimelea kuzoea dawa. Kiwango kinachopendekezwa cha amji kwa hekta ni lita 1000.

**DESCRIPTION:** Pearl 80DF is a Fungicide to control Botrytis on Roses and Snow peas.

**MODE OF ACTION:** Systemic fungicide with protective and curative action.

**RECOMMENDATIONS:** Best results are achieved when Pearl 80DF is applied preventively as it inhibits spore germination but will also check the spread of disease if applied post infection. Alternate Pearl 80DF with other fungicides with a different mode of action to avoid resistance build up. Use a volume of 1000 litres of water per hectare.

**APPLICATION RATES:**

**REI (Re- entry Interval):** 12hrs from last application.

**PREPARATION OF SPRAY:** Measure the required quantity of Pearl 80DF and add a small volume of the required volume of water to make a thick uniform paste. Allow to soak and then add the remaining quantity of water slowly while stirring continuously and continue agitating even while spraying.

**PRECAUTIONS:** Do not smoke, eat or drink when using this product. Do not inhale the spray mist. Wear protective clothing; boots, gloves, masks and a face shield when spraying this product.

**STORAGE AND DISPOSAL:** Store in original container, away from children and livestock. Store in a cool, dry and dark place. Triple rinse empty pouch and add washings to spray mixture, then dispose empty container in a safe and authorised place away from human habitation and water sources, in accordance with national regulations and legislation. Do not reuse containers for any other purpose.
