

DESCRIPTION: MOSTHRIN 2.5 EC is a public health insecticide for the control of adult mosquitoes.

DIRECTION FOR USE: Apply as a spray 20ml in 20 litres of water to walls, ceiling and beams of animal sheds, verandas and buildings where flies and mosquitoes are a nuisance. Spray also areas outside where mosquitoes hide etc. 10 litres of spray will cover upto 100 M². Apply also in animal sheds

PRECAUTIONS: Wear suitable protective clothing e.g. face shield for eye/face protection, gloves and masks when handling the concentrate and mixture. Do not smoke, eat or drink when handling. Harmful if swallowed or inhaled and may cause irritation on contact with skin and eyes. Risk of serious damage to eyes. Do not spray against the wind. Wash with soap and water and change clothes after application.

STORAGE: Store in original tightly closed container, away from children and livestock. Store in a cool, dry and dark place.

DISPOSAL: Triple rinse empty container and add washings to spray mixture, perforate or puncture holes on empty container then dispose empty container in a safe and authorised place away from human habitation and water sources, in accordance with national regulations and legislation. Do not reuse containers for any other purpose.

ENVIRONMENTAL HAZARDS: MOSTHRIN 2.5 EC has little toxicity to animals but avoid direct spraying on grass or animal feeds. Toxic to fish and other aquatic micro-organisms. Do not contaminate ponds or water sources with chemical or used containers.

FIRST AID INSTRUCTIONS: **Inhalation:** Remove victim to fresh air. **Skin contact:** Wash the victim with soap and rinse with abundant water. **Eye contact:** Wash eyes with running water for 15 minutes and refer victim to doctor. **If Ingested:** Do not induce vomiting, give activated charcoal.

TOXICOLOGICAL INFORMATION: Symptoms of poisoning: Nervousness, anxiety, tremors, convulsions. **Antidote:** No specific antidote

NOTES TO PHYSICIAN: Induce vomiting by syrup of Ipecac (Adults and older children -30ml Children under 12years -15ml) followed by 1-2 glasses of water. Give 30-50gm of activated charcoal in 90-120ml water to limit absorption of remaining toxicant. Treat symptomatically.

JINSI YA KUTUMIA: Changanya mililita 20 za MOSTHRIN 2.5 EC na lita 20 ya maji. Nyunyizia kwenye kuta, dari na mihimili ya wanyama, verandas na majengo ambapo na mbu ni kero na kadhalika. Lita 10 ya dawa yaweza Nyunyizia eneo la mita 100. Hutumika pia katika eneo la wanyama

TAHADHARI: Vaa mavazi ya kinga, overalls, kofia, mifuko ya mikonono, masks, gumboot, miwani ya uso n.k. unapotumia kiuwatilifu hiki. Usile, kunywa, wala kuvuta sigara unapotumia kiuwatilifu hiki. Usinyunyizie kiuwatilifu hiki kuelekeza upande upepo unakotoka, ili kuepuka kuuvuta mvuke wake. Oga kwa sabuni na maji mengi, kisha badilisha nguo b aada ya kunyunyiza dawa.
