

**DESCRIPTION:** OXYGOLD 24 EC is a selective pre-emergence herbicide for controlling broadleaf weeds and annual grasses in Tomato, Cabbage and onions. The product should be applied before weed emergence. After weeds or soil surfaces are sprayed with OXYGOLD 24 EC they should not be disturbed in any manner. Emerging weeds get into contact with the herbicide layer as they break the soil surface. The emerging shoots take up the herbicide as they break the soil surface. Rain or irrigation is essential for activation of the residual effect of OXYGOLD 24 EC. Application to hot dry soil reduces efficacy, so apply when the soil is wet from irrigation or recent rain.

**MODE OF ACTION:** Selective contact herbicide, absorbed more readily by the foliage (and especially the shoots) than by the roots, with very little translocation. As a pre-emergence, it forms a thin layer on soil after activation with water. Susceptible species absorb OXYGOLD 24 EC through the hypocotyls, at the germination stage.

**RATE OF APPLICATION:**

**Preharvest interval:** Onions-118 days, Cabbage - 60 days, Tomatoes - 60 days.

**STORAGE AND DISPOSAL:** Store in original tightly closed container in a cool, dry and well ventilated place away from children, livestock and foodstuff. Destroy empty containers by triple rinsing, puncturing and burying in an approved place away from water sources and human habitation, in accordance with national regulations and legislation. Do not reuse the containers for any other purpose.

**ENVIRONMENTAL HAZARDS:** Keep livestock away from treated field for at least 24 hours. OXYGOLD 24 EC is highly toxic to fish. Do not contaminate water sources, ponds or ditches with the concentrate, its solution or empty containers.

**First Aid Measures: Skin contact:** Immediately wash with plenty of soap and water for at least 5 minutes. Seek medical attention if irritation develops or persists. Remove contaminated clothing and shoes. Clean contaminated clothing and shoes before re-use. **Eye contact:** Hold eyelids open and flush with a steady, gentle stream of water for at least 15 minutes. Seek medical attention. **Inhalation:** Immediately leave the contaminated area, remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Call a physician immediately if symptoms developed. **Ingestion:** Wash out mouth with plenty of water. Get medical attention. Never give anything by mouth to an unconscious person. REFER VICTIM TO DOCTOR.

**Symptoms of poisoning:** No specific symptoms available for this particular chemical. Involved minor symptoms of systemic illness such as headache, dizziness and nausea. Formulations may cause severe skin and eye irritation.


**Antidote:** There is no specific antidote. Treat symptomatically, and give supportive therapy.

**Treatment:** Remove victim from area of exposure. Wash off remaining material with plenty of water. All treatments should be based on observed signs and symptoms of distress in the patient. If lavage is performed, endotracheal and/or esophageal control is suggested. Danger from lung aspiration must be weighed against toxicity when considering emptying the stomach. The decision of whether to induce vomiting or not should be made by a physician. Maintain adequate ventilation and oxygenation of the patient.
